- 1. COVID-19 Update

 - Cancelling class/Closing during weather events how will it work?
 - SCSU has new people in these positions as well. They have already reached out about working together.
 - Shared with Deans Deans are going to discuss with faculty about handling it as program based.
 - Faculty have not been able to do this in the past. **Follow up information**: faculty have been able to decide not to teach their own class on inclement weather days.
 - o SCTCC will not be closing campus, it is complicated with teleworking.
 - The System Office is working on how pay and leave time would look if a campus needs to close and has people teleworking.
 - A concern was brought up regarding students not cleaning their area in classrooms when they leave. Chairs are also not being reset. **Follow up information:** In reviewing the Covid Return Plan, it identifies that students should clean their area when they arrive, not exiting students. Classrooms have been set for social distancing so chairs should remain where they are and if they get moved, reset so entering students can practice social distancing.

- 5. Alleged hazardous working conditions HSB water update
 - Late in the afternoon on Tuesday, October 20, 2020, a work order was submitted to the Facilities Department reporting what appeared to be green algae and green water coming out of a single tap in the Health Sciences Building. The work order was read and immediately investigated at 7:00 a.m. on Wednesday, October 21st.

It was discovered that the substance was from a piece of pipe that was replaced on the main water line that feeds the west end of the Health Sciences Building. Impacted areas included only the west side of the building. As a precautionary measure, the water in the entire building was tested and treated. Test results indicated no coliform bacteria was present and the water was safe for use.

- A concern was brought up regarding how the building was evacuated. Rita shared that her class was told there was a
 broken water pipe and that chlorine was in the air and everyone needed to evacuate immediately. Rita reports that
 this caused a chaotic situation and Covid safety was not followed.
 - Follow up information: A debriefing of the incident occurred with Jason Theisen, Carol Brewer & Lori Kloos. Concerns over the evacuation communication was discussed and steps have been identified to prevent this from happening again.
- 6. Follow-up on action items from previous safety committee meetings
 - A contract with SCSU for patrol officers was renewed for this upcoming year.
 - A contract with SCPD was also renewed to have an officer on campus. The committee would like for the previous
