Health programs have specific requirements for students to complete.

Dental Hygienist Program Description

The Dental Hygienist Program is a full-time, 4-semester program.

- Dental Hygienist program begins each fall semester.
- 14 students are accepted each fall semester.
- 4 semesters: fall, spring, fall, spring

It is a competitive program that requires a thorough application process.

With a dental hygiene degree from SCTCC, graduates are licensed primary healthcare professionals. After learning skills in the classroom, students will take The National Board Dental Hygiene Exam (NBDHE), a clinical board exam, jurisprudence, or state laws exam, and then obtain a license in the state they wish to practice., and then get a license in the state where they want to practice.

Hygienists work in clinical dental settings and provide preventative, educational, and therapeutic services to patients. By promoting public health, dental hygienists help people learn the importance of dental health. Duties include patient assessment, teeth cleaning, taking radiographs and dental images, applying fluoride treatments, providing periodontal therapy, and administering local anesthesia and nitrous oxide/oxygen inhalation.

Dental Hygienist Careers

Potential employers include clinical dental offices, nursing homes, public health agencies, dental and pharmaceutical companies, teaching in dental hygiene education programs and doing dental research.

- The two-year placement rate for the Dental Hygienist program is 100%.
- The average Central MN annual salary range is \$62k to \$81k.

Prospective/Returning Student - Application Process

- Your first step is to apply to SCTCC as a Pre-Dental Hygienist student at https://sctcc.edu/apply
- Follow instructions received by Admissions and Records & Registration offices.
- Meet with an advisor to begin the *Current SCTCC Student* process.

Current SCTCC Student / Advisor Meetings - Academic Advising Center

- Current SCTCC students are required to meet with an advisor at least once a semester to receive a registration access code and review their academic plan.
- We encourage students to visit more often with any questions or concerns they may have.
- We are here to align you with resources that are available and help guide you through your educational journey at SCTCC!



Dental Hygienist Program Requirements / Planner

- A minimum grade of "C" or better AND a cumulative GPA of 3.0 or above in pre-requisite coursework is required to be considered for admission and must be maintained in the program.
- ALL pre-requisites **MUST** be complete before applying to the program.
- When applying to the program, applicants must be in *Good Academic Standing* at SCTCC
 - Not on warning or probation cumulative GPA 2.0 & cumulative completion rate of 66.67%.
- **<u>Re-take Options</u>**: Pre-requisites may be taken 3 times (effective December 2022).
 - \circ \quad Consult with an advisor about the impact of repeated courses
- Program application dates and periods may vary and/or be extended. Priority is given to those who apply during the first application period. Stay up to date by checking the program page frequently.
- The Dental Hygiene program is <u>highly competitive</u>, the college may not be able to accept all applicants that meet the minimum admission standards.

- Mid-Late February qualified applicants will be invited and take the HESI exam
 - Dates are estimated and subject to change. Review Dental Hygiene page for updates.
- 7 weeks after application period closes:
 - o <u>Accepted</u> applicants will have letters sent
 - Top 14 ranking students
 - <u>Alternate List</u> applicants will be notified of their status
 - **Non-accepted** applicants are notified & encouraged to meet with an advisor to discuss:
 - ways to improve your application before reapplying to the program
 - your educational options / course selection for next semester
 - other programs and opportunities at SCTCC

Students admitted to the Dental Hygienist program

- Applicants will be notified of the date and time for the mandatory Dental Hygienist student orientation, usually held in May.
- Applicants MUST provide documentation of either Basic Life Support (BLS) American Heart Association <u>OR</u> American Red Cross CPR Certification (during orientation meeting).
- Applicants will be required to take and pass a MN Criminal Background study, electronic fingerprinting, AND drug testing (paid for by the student).

Applicants placed on the Alternate List for the Dental Hygienist program

- Applicants who meet the requirements but were not admitted because the
- program was full will be placed on a ranked alternate list.
 - Applicants placed on this list will be eligible for admission to the program if spaces open prior to the beginning of the fall semester.
 - ALL applicants who wish to gain admission to the Dental Hygienist Program in the future must reapply, including those who were on the previous year's alternate list.

***If an applicant is accepted and declines to be admitted into the program, no preference will be given to the applicant should they choose to apply in any subsequent year. To be considered for admission in any subsequent year, students will be required to repeat the application process in its entirety.

FAQs – Dental Hygienist Program

Can I apply directly to the Dental Hygienist program?

Students MUST be a *Current Student* (applied and accepted to SCTCC).

Can I apply to the program without all of the pre-requisites complete?

All pre-requisite courses MUST be complete prior to applying to the program with a minimum GPA of 3.0 earned in these courses.

Can I re-take a pre-requisite course to improve my GPA?

Each pre-requisite may be taken 3 times (Effective 12/2022)

• Consult with an advisor about the impact of repeated courses.

Beside my Pre-Requisite GPA, what can I do to improve program acceptance?

When does the Dental Hygienist program start?

The Dental Hygienist program is a 4-semester program that begins each Fall Semester.

How many students are accepted?

14 students are accepted each Fall Semester.

Can I attend Part-Time?

The Dental Hygienist program is a *full-time* program only.

Can I take the Dental Hygiene classes online?

Once accepted to the program, classes are all held on-campus or at Clinical sites.

When can I apply to the program?

The Dental Hygienist application window is open December 1st through January 15th

Once accepted to the Dental Hygienist program, what is the schedule like?

First year classes (semester 1 & 2) are held Mon-Friday from 9:00 AM- 5:00 PM

(8 hours a week in lab, 12 hours of lecture/didactic and additional open lab practice sessions).

- Study time and practice time is roughly double time spent in classes.
- The focus is on learning dental hygiene theory, terminology, and basic clinic skills.
- Students will start seeing dental patients in spring of second semester.

Second year classes (semester 3 & 4) are 4-5 days per week depending on the semester.

- Majority of hours per week in the dental clinic with patients (12 hours per week).
- Lecture and lab hours amount to 10-12 hours per week.
- Additional time is spent on skills and practicing with instruments and equipment to increase experience and competency.
- Spring (semester 4) includes off campus activities at various community dental health sites providing oral hygiene instruction to underserved populations in the community.

Is the Dental Hygienist Program accredited?

The St. Cloud Technical and Community College (SCTCC) Dental Hygienist program is accredited by the <u>Commission on</u> <u>Dental Accreditation</u>.

St. Cloud Technical & Community College is accredited by the Higher Learning Commission.



Dental Hygiene Program and HESI Admission Assessment Exam (A2)

What does HESI stand for?

Health Education Systems, Inc., and A2 stands for Admission Assessment.

Why is the HESI admission exam being used?

The HESI exam is being used by the Dental Hygiene Program to help evaluate students' academic readiness as part of the selection process.

Students will also be completing a learning style and personality profile assessment.

The learning style and personality profile assessment will not be scored.

When can I take the HESI exam?

Students MUST be invited to take the HESI exam at SCTCC. Students are invited to take the HESI exam after the Dental Hygiene Program applications have been reviewed.

Students that have completed all program requirements and scored a minimum required GPA of 3.0 for the required prerequisites will be eligible to take the HESI examination.

Explicit directions are included in the invitation that is sent via email and mailed letter.

What is covered in the HESI exam?

Eligible students will take the following components of the HESI exam for application to the Dental Hygiene Program:

English:

- Reading Comprehension (60 minutes)
- Vocabulary and General Knowledge (50 minutes)

Science:

- Biology (25 minutes)
- Anatomy and Physiology (25 minutes)

Learner Profile:

- Learning Style (14 items)
 - These scores are not scored for program admission
- Personality Profile (15 items)
 - These scores are not scored for program admission

How long will the HESI exam take?

Applicants should allow about 4 hours to complete the exam (all components listed above). Registration is a separate process and will be done prior to taking the actual exam. Details are explained in the invitation letter.

What is the cost of the HESI examination?

The test will cost approximately \$60 -\$70 (Fees will be set on the HESI site each year)

Students will register online and pay for the exam online.

Testing location:

Students will take the exam at SCTCC in a testing lab at the main campus (1540 Northway Drive).

What are the student accommodations?

Students will be permitted the use of scratch paper if deemed necessary, which will be collected by the SCTCC Testing Center staff and immediately shredded after the test.

How many times can I take the HESI exam?

Students are allowed to take the test two (2) times for their dental hygiene application process.

The HESI exam must be taken at St. Cloud Technical & Community College (or by using ProctorU as determined by the college) and will only be offered once each year in February.

Students are encouraged to re-test to boost scores for program admission.

Is there an expiration date of my HESI exam?

The HESI exam must be taken within two years of applying to the Dental Hygiene Program for the score to be eligible for consideration in the selection process.

When will the HESI exam be administered?

The testing window for the Dental Hygiene HESI exam is offered mid-to-late February each year.

Eligible students will receive an email with detailed information & dates. Once the Dental Hygiene application period closes, applications are reviewed and ranked.

Eligible applicants will be notified and invited to the HESI exam.



Dental Hygiene Program and HESI Admission Assessment Exam (A2)

What is the minimum score accepted for the HESI exam?

There is not a minimum score needed to achieve for admission to the Dental Hygiene Program. Students will receive points based off their comprehensive score based on a percent set forth by program.

When will I know the results of the HESI exam?

Within 48 hours students will receive a detailed email regarding their score.

How can I study for the HESI exam?

Students are encouraged to study and prepare for all portions of the HESI A2 Exam required for dental hygiene program admissions. Study material sources are suggested on the Evolve Elsevier website and Amazon.
